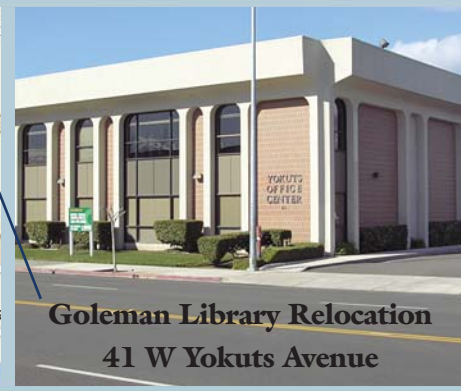

Citizens' Oversight Committee -

As required by Education Code Section 15278, a Citizens' Oversight Committee was formed by the San Joaquin Delta Community College District's Board of Trustees. The Committee is responsible for reviewing expenditures related to the College's \$250 million general obligation bond, Measure L, approved by the voters on March 2, 2004. Meetings are held quarterly and are open to the public. The Committee is comprised of several Members-at-Large as well as representatives associated with the following constituent groups: Senior Citizen, Business, Foundation, Taxpayers Association, and Student. On the Move! *Department relocations will take place to accommodate Goleman renovations.*

In anticipation of the Goleman Building renovation, plans are underway for the relocation of the departments housed there.

Financial Aid and Veterans Services is preparing to relocate to 5405 N Pershing Avenue, Suite A. In order to avoid an interruption

Relocation plans are also underway for the Goleman Library. The move is tentatively scheduled for

June of 2008, at which time a move will be made to 41 W Yokuts Ave. While in the temporary location Goleman Library plans to continue offering all of its standard services. Details regarding the relocation and temporary facility will be made available as plans are finalized.



Mountain House Village Coming Together

In order to accommodate increasing enrollment demands in the south county as early as possible, Delta College has purchased relocatable classroom units for use at Mt. House.

The units (illustrated above) will provide 35,000 square feet of space comprised of classrooms, wet and dry labs, technology rooms, offices, and lavatory facilities. Once these units are in place at Mt. House they will be able to serve the full needs of a

compact college community during construction of the permanent facilities.

Approximately a quarter of the relocatables were acquired through an agreement with the Merced Community College District. Merced had several two year old science labs that were no longer being used, allowing Delta to purchase them for a fraction of the cost of new units. The majority of the relocatable classrooms will be purchased from

Williams Scotsman, a national leader in supplying relocatable instructional space.

At this time, the units from Merced are on the Manteca campus, and the new units are being manufactured to college specifications, which include significant technology upgrades.

It is anticipated that the units will be placed at the Mt. House site over the summer, and are scheduled for Fall 2008 occupancy.
